The WDSF Rules state:

1. Every WDSF licensed Adjudicator and Chairman has to attend a minimum of 1 WDSF Adjudicators Congress every 2 years (alternate year).
2. In a case of non-compliance the license will be suspended (“Inactive”) until the condition is fulfilled.

#### **General Knowledge Test (GKT)**

With effect from July 2013 all applicants for WDSF Adjudicator's License must pass this test as a prerequisite to obtaining a license.

Existing license holders will sit for the test at their convenience when they attend the Adjudicator's congress for license renewal or just to sit for a test at a congress of their choice. Adjudicators who have passed the test will have a special credit note on the WDSF website. The GK test will be administered every 4 years when the adjudicators attend a new congress for upgrading and to maintain an “active” status.
