This was done to for several reasons including following WDSF guidelines. After the DSC meeting, the NDCA took action against their member adjudicators, so several NDCA adjudicators cancelled their NQE contracts. With not publishing our adjudicating panel names, several USA Dance members felt that NQE organizers were “hiding” their adjudicating panel names because of hiring “inferior” adjudicators. This motion reverses the motion approved by the DSC in August 2014, so that rule 5.6.2 would remain the same and NQE organizers could publish their Adjudication panel members.
